1 - Introduction and Acceptance of the Terms

Welcome to Hydra Technologies, also known as "Hydra Tech". By accessing and using this service (the "Service"), you ("you", "your") accept and agree to be bound by the terms and provisions of this agreement. This means you shall be subject to any posted guidelines or rules applicable to the services provided, which may be posted and modified from time to time, which we may do for reasons that include but are not limited to, complying with changes to the law or reflecting enhancements to the Service. 8 - Prohibited Activities
